# ARTICLE 1 - Organization

The Creative Photo Award was created by the Riedisheim Photo Salon, in partnership with the company Super U Riedisheim.

This prize is organized outside patronage.

### ARTICLE 2 - General conditions of participation

### 2.1 Participants

This contest is open to all photographers, excluding jury members. Only one entry per person is accepted.

### 2.2 Purpose of the contest - Theme definition

The Salon Photo Riedisheim seeks to develop photographic creation. Creativity is a form of humanism. It pushes the photographer to engage in his ideas, combining imagination, innovation and originality. Any form of creativity is free, within the limit of a digital image.

The Creative Photo Award Super U Riedisheim will be judged exclusively in digital images.

The ten best authors who have proposed an original and innovative photography will be rewarded by the exhibition of their work at the Salon Photo Riedisheim from 14 to 22 March 2020 and on its website.

The Photo Award U U Riedisheim will reward the three authors who have proposed the most original and innovative photographs.

### 2.3 Exclusions

Contest organizers reserve the right to remove from the contest any pornographic, pedophile, racist, discriminatory or other types of photos repressed by applicable law. The participant can not in any case contest the decision of the organizers.

### ARTICLE 3 - Registration and deadline of deposit

Registrations must be submitted no later than midnight on January 5, 2020 according to the terms and conditions indicated on the website www.spr-photo.fr.

### ARTICLE 4 - Terms of participation

The flat fee is 20 € for a maximum deposit of 4 photos. Only one entry per person is accepted.

Each participant will deposit his or her photographs on the platform of the contest website in digital format JPG respecting the resizing indicated, namely 3840 pixels on the longest side, within the limit of 6 MB per photo. Any logo, any distinctive sign or signature affixed to the photograph is forbidden.

Participation in the contest entitles you to a digital catalog of the exhibition.

### ARTICLE 5 - Jury and prize

The jury will be composed of two members of the organizing committee of the Salon Photo Riedisheim and two photographers from outside the committee.

Jury members from the organizing committee of the Salon Photo de Riedisheim : Roselyne Liechty Dominique Eckenfels,

Non-committee jury members : Julie from Waroquier Franco Sicari

This Jury will select the 10 works that will be exhibited at the show and the winners of the Prize. The jury's decisions are final.

The exhibition will print the photos that will be exhibited.

The first winner of the Creative Photo Award Super U Riedisheim will be rewarded by the payment of a sum of 1000 € (one thousand). The second winner will be rewarded with the payment of € 500 (five hundred) and the third with a payment of € 300 (three hundred).

The prices are offered by the company Super U Riedisheim and the Salon Photo Riedisheim.

## ARTICLE 6 - Announcement of the result and awarding of the prizes

The Super U Riedisheim Creative Photo Award will be presented at the opening of the Riedisheim Photo Salon on Friday 13 March 2020.

The winners will be informed by email and the ranking will be published on the Riedisheim Photo Salon website on February 18, 2020.

### ARTICLE 7 - Intellectual property rights and use of photographs

Each participant declares to be the author of the submitted photo (s). The author of a photograph undertakes to respect the right of intellectual property and to involve only images made by him alone. He also acknowledges having previously obtained the necessary authorizations for their distribution, including identifiable persons in the photos. In case of proven fraud, the author will be purely and simply excluded from the competition without notice.

The author authorizes the Salon Photo Riedisheim to reproduce and distribute his work in the sole context of the promotion of the contest and the resulting exhibition, in digital and paper, on its website and Facebook page, without compensation of some kind.

### ARTICLE 8 - Liability

The organizers can not be held responsible in case of partial or total loss of the digital data or the cancellation of this contest in case of force majeure or if the circumstances required it. Participants have the right to withdraw or correct their personal data. The Salon Photo Riedisheim can not be held responsible for technical malfunctions such as line interruption, network, server problem, etc. that could prevent the delivery of images. The Salon Photo Riedisheim can not be held responsible if, for any reason, the photo of a candidate can not be viewed or can be managed as expected. The accidental loss or destruction of a file by the organization can not give rise to any compensation. Participation in the contest can not give rise to any compensation, reimbursement or financial compensation.

# ARTICLE 9 - Obligations

By participating in this contest, the author declares to accept and respect without reservation the present rules by digital signature when registering online.

Failure to do so will result in the cancellation of the application. Any dispute concerning the interpretation and application of these rules will be considered by the organizers, who are sovereign in their decision, in the spirit that prevailed in the design of the contest.
